#### ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM

I acknowledge that this Accident Waiver and Release of Liability Form will be used by the organizers of the Sunshine Swim and Event Center, LLC., in which I may participate and that it will govern my actions and responsibilities at said Sunshine Swim and Event Center. In consideration of my application and permitting me to participate in Sunshine Swim and Event Center, LLC., programs, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A)I WAIVE, RELEASE, AND DISCHARGE Sunshine Swim and Event Center LLC., managers, employees, contractors, volunteers and their property management company and its employees, contractors from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from Sunshine Swim and Event Center. At which time a revision will be drawn up and signed by all parties.
